## REVENUE ANTICIPATION NOTE RESOLUTION DATED: MAY 3, 2017

A RESOLUTION DELEGATING TO THE PRESIDENT OF THE BOARD OF EDUCATION OF THE ENLARGED OGDENSBURG CITY SCHOOL DISTRICT, COUNTY OF ST. LAWRENCE, THE POWER TO AUTHORIZE THE ISSUANCE OF AND TO SELL NOT EXCEEDING \$3,500,000 REVENUE ANTICIPATION NOTES, 2017 OF SAID DISTRICT IN ANTICIPATION OF THE RECEIPT OF STATE AID DURING THE FISCAL YEAR OF SAID DISTRICT COMMENCING JULY 1, 2017 AND ENDING JUNE 30, 2018.

**BE IT RESOLVED**, by the Board of Education of the Enlarged Ogdensburg City School District (the "District"), County of St. Lawrence, as follows:

Section 1. Pursuant to Sections 30 and 56 of the Local Finance Law, revenue anticipation notes of the District are hereby authorized to be issued pursuant to the provisions of the Local Finance Law of the State of New York (the "Local Finance Law"), in a principal amount not to exceed \$3,500,000.

Section 2. The power to authorize the issuance of and to sell not exceeding \$3,500,000 revenue anticipation notes of the District, including renewals thereof, in anticipation of the receipt of state and federal aid becoming due during the fiscal year of said District commencing July 1, 2017 and ending June 30, 2018, is hereby delegated to the President of the Board of Education, the chief fiscal officer. Such notes shall be of such terms, form and contents, and shall be sold in such manner as may be determined by said President of the Board of Education, pursuant to the Local Finance Law.

Section 3. The estimated amount of uncollected revenues against which such revenue anticipation notes are authorized is \$3,500,000.

<u>Section 4.</u> The period of maturity of such revenue anticipation notes shall be one year.

<u>Section 5</u>. This resolution shall take effect immediately.
