### **Report 8:**

2019-2020 Budget Update

The new packet contains a list of proposed reductions for the 2019-2020 budget. The list is based on the recommendations provided by the board, including a 1.2 million dollar fund balance appropriated and 2.5 % tax cap of property taxes. The increase of 2.9 million includes debt services, an increase of special education requirements and an increase in transportation.

If the proposed list of cuts is enacted class size and course availability will be affected. Required course credits and class period lengths will change as well. A resource officer is included in the

2019-2020 budget. The first years projected cost is \$39,640, with an increase to \$67,440 in the second year. Next steps will include looking at options for debt services, the tax cap and fund balance appropriations.
