REASON FOR BOARD CONSIDERATION:

Newell, II Memorial Golden Dome (SED Control No. 51-23-00-01-0-007-022), **WHEREAS**, pursuant to SEQR, the Board desires to determine whether the Action may have significant adverse impact on the environment (as defined by SEQR); and
