SUBJECT: RE-ADOPTION OF SUBSTITUTE TEACHER/TEACHING ASSISTANT/SCHOOL NURSE COMPENSATION SCHEDULE

REASON FOR BOARD CONSIDERATION:

The Board of Education sets hourly wages for Substitute Teachers, Substitute Teaching Assistants, and Substitute School Nurses.

FACTS AND ANALYSIS:

A new compensation schedule is requested for Substitute Teaching Assistants. The current daily rate for Substitute Teaching Assistants does not meet the State Requirement for minimum wage. Therefore, the following is the recommended action:

Moved by _____ and supported by _____ resolved, that having the approval of the Superintendent of Schools, the Board of Education of the Ogdensburg City School District does hereby authorize the following COMPENSATION SCHEDULE for SUBSTITUE TEACHERS, SUBSTITUTE TEACHING ASSISTANTS, AND SUBSTITUTE SCHOOL NURSES effective December 31, 2017:

TITLE	COMPENSATION SCHEDULE (Daily Rate)
Retired New York State Certified Teacher	\$135.00
BA/BS/Certified Substitute Teacher	\$85.00
Uncertified Substitute Teacher	\$75.00
Substitute Teaching Assistant	\$73.00
Substitute School Nurse	\$135.00

- Long-Term Replacement >20 days, daily rate increases by \$23.00, pay will be retroactive to first day.
- Long-Term Replacement >60 days, paid the per-diem rate of a teacher (BA+30, STEP 1), pay will be retroactive to first day.
- If leave is known to be >60 days, rate will begin immediately on the first day.
- If length of leave is not known and becomes >60 days, pay will be retroactive to first day.
