	The Board of Education must approve all changes to the 2019-2020 tax levy.
FACTS AND ANALYSIS	5:
	As defined in Section 550 of the Real Property Tax Law, the St. Lawrence County Real Property Tax Service Agency has notified the Ogdensburg City School District that due to a clerical error by the City of Ogdensburg Assessor, parcel # 48.072-8-35./1 must be removed from the Ogdensburg City School District tax roll. Therefore; \$4,954.80 school tax and \$59.84 library tax is removed from the tax payer's 2019-2020 school tax bill in the total amount of \$5,014.64, and a new school tax bill has been issued. The subtraction of the school and library tax decreases the school and library tax levies in the total amount of \$5,014.64.
