**FACTS AND ANALYSIS:**

All health services, policies and procedures will be subject to the rules and regulations of **New York State Education Law Article 19-Medical and Health Services** for the promotion of the health and well being of all students within the public school system of New York State. Therefore, all health services provided within the Ogdensburg City School District will be mandated by Article 19. Such policies are included in the Ogdensburg City School District Health Services Policy Manual. Mrs. Tara Kroeger, BSN, RN, Nursing Supervisor, has reviewed and updated the district's Health Services Policy Manual for the 2020-2021 school year. Mrs. Kroeger, BSN, RN, would like to note that the NYSDOH is reviewing the current immunization guidance for schools, when the 2020-2021 Immunization Requirements Chart is available the district's manual will be updated. Several minor changes have been made to the Ogdensburg City School District Health Services Policy Manual for the 2020-2021 school year.

I have a few minor changes for the 2020-2021 Ogdensburg City School District Health Services Policy Manual as listed below:

- Page 7- Immunization Requirements Chart 2019-2020  
Per the NYS Department of Health, the new chart for 2020-2021 is not yet available. I spoke with Mrs. Kelly about it and we decided to leave the 2019-2020 chart in the Manual with a footnote stating **\* NOTE: The NYSDOH is reviewing the current immunization guidance for schools. When the 2020-2021 Immunization Chart is available, the manual will be updated.**
- Page 9-Religious Exemptions  
Leave red portion of paragraph regarding religious exemptions as is.  
Delete the black portion of the paragraph starting with **"Children, who previously had a religious exemption...**
- page 20- letter g  
**Change:** The following Zurich Progressive Exertion Protocol **may** be used as a guide to graduated return to activities:  
**To:** The following Zurich Progressive Exertion Protocol **will** be used as a guide to graduated return to activities unless otherwise directed by physician:
- underneath that paragraph:  
**Remove** the word "nurse" from the statement: The above guide may be modified by the Medical Director/**Nurse** on a case-by-case basis.  
**Change To:** The above guide may be modified by the Medical Director on a case-by-case basis.
- Page 23-Mandated School Survey Opt-Out Form  
Change date to 2020-2021 School Year
